

Trustee 341 Filer Enhancement

The 341 filer program has been enhanced to give the trustee the ability to continue multiple meetings at once. There is a new filter screen asking the filer if they want to continue multiple meetings and also gives the user the ability to enter additional docket text –

This screen displays all cases for which the trustee has a 341 meeting scheduled on the selected day. The trustee makes date, time and location selections. The additional docket text field allows the trustee to add information to the docket text; to add text indicating whether the debtor(s) appeared, the user may make selections from the radio buttons to the right.

If the trustee runs the report without selecting the “Continue multiple 341 meetings” box, the Trustee’s 341 Filings screen is displayed:
