The United States Bankruptcy Court for the District of Rhode Island (Court) is seeking quotes for monthly parking arrangements. This is a request for **Open Market Pricing**. Pricing is being solicited to award one of the following¹:

- A 12 month contract with one (1) option to renew for an additional one (1) year;
- A 24 month multi-year contract;

REQUIREMENTS:

- 1. Parking spaces not to exceed 11 vehicles;
- 2. Parking availability Monday through Sunday (24/7);
- 3. Flexibility to allow ad hoc usage of unused parking spaces to court personnel as needed [seven (7) court staff members telework one day each week];

¹ Base year (Option to Renew) commits the Court to a one-year contract. The Court *may* renew the contract for the additional 12 months at the pricing quoted in this RFQ however, we have the option to let the contract expire after the end of the first year. Multi-year contracts commit the Court to a contract for the entire length of time specified.

- 4. Monthly billing statements;
- 5. Open air parking only;
- 6. Parking spots can be no further than 30 yards from the perimeter of the Federal Center, 380 Westminster Street, Providence, RI
- 7. In and out privileges during the day.

EXERCISING OPTION YEARS:

If the contract is awarded on the terms of base year plus options, the Court will notify the service provider at least thirty (30) days prior to the end of the contract year if it will exercise the right to utilize the subsequent option year term.

PURCHASE ORDER TERMS AND CONDITIONS Provisions and Clauses
