#### What is the Foreclosure Prevention Project?

The Rhode Island Bar Association's Foreclosure Prevention Project is specifically designed to help citizens at risk of losing their homes. Coordinated with the Rhode Island Bar Association's Public Service Programs, volunteer attorneys directly represent clients in many areas of civil law to avoid foreclosure. These areas of law may include Family Law, Benefits, Bankruptcy, Loan Modifications, Probate among others.

## How Does the Foreclosure Prevention Project Work?

If you or a family member are experiencing financial issues that may lead to the loss of vour home, call the Foreclosure Prevention Project. You will speak to a staff member who will ask some questions about your legal problem. Any information you give will be held in the strictest confidence. After your interview, if you are eligible, a staff member will contact an attorney who has expertise in handling cases such as yours. If we are able to place your case, you will be given the attorney's name and telephone number and instructed to call his/her office to arrange your first appointment. At this point, all services provided for you by the attorney will be free of charge. You may be required to pay court fees or other minor litigation costs.

#### Don't Wait, Get Help Now!

You may need assistance if you own a home and are having trouble paying your mortgage or anticipate future problems and have experienced a loss of income due to:

- Loss of Employment/Salary decrease
- Divorce/Separation
- Death of a Family Member
