## **POSITION SUMMARY:**

The United States Bankruptcy Court for the District of Rhode Island is seeking a chambers paralegal for the chambers of United States Bankruptcy Judge John A. Dorsey. A chambers paralegal performs administrative and legal duties in support of the Judge, the Career Law Clerk, and the Court generally.

## REPRESENTATIVE DUTIES AND RESPONSIBILITIES:

The paralegal will provide a variety of support services, including, but not limited to: preparing correspondence, reports, and required disclosures; making travel arrangements; preparing expense reports; maintaining a conflict-checking database; organizing and managing Court-related events; maintaining office functionality and scheduling; managing procurement; coordinating with the Clerk's Office, IT staff, and other Court departments; reviewing legal submissions; performing legal research; drafting, proofreading, and editing legal documents and orders for review; performing case management through the CM/ECF (Case Management / Electronic Case Filing) system; addressing a wide assortment of issues arising in bankruptcy cases and proceedings; and other duties as assigned by the Judge.

# PREFERRED QUALIFICATIONS:

Experience as a paralegal in a judge's chambers or law office. Familiarity with CM/ECF; Microsoft Outlook, Word, Teams, SharePoint, and OneDrive; Adobe Acrobat; Zoom; and Westlaw and/or Lexis.

## **MINIMUM QUALIFICATIONS:**

- Bachelor's or Associate's degree.
- Paralegal certificate from an accredited college or university.
- Strong administrative and legal background.
- Excellent administrative, organizational, and oral and written communication skills.
