# Bankruptcy Administration Improvement Act (BAIA)

- The BAIA, Pub. L. No. 116-325 (BAIA), was enacted on January 12, 2021.
- It amends the Bankruptcy Code to include a new subsection 330(e) that establishes a new payment for trustees serving in chapter 7 bankruptcy cases.
- These payments are funded from chapter 11 quarterly fees collected by the Department of Justice (DOJ) and deposited in the United States Trustee System Fund.

# § 330(b) Payments vs § 330(e) Payments

- The [Section 330\(b\)](#) payment is funded by the filing fees collected in a chapter 7 case. Therefore, the §330(b) payment is dependent upon the filing fees being collected in order to pay the trustee in a particular case. This payment may also be impacted if the filing fees are waived pursuant to [28 U.S.C. 1930\(f\)](#).
- The [Section 330\(e\)](#) payment has a separate funding source not related to the collection of any filing fees. Thus, if the chapter 7 trustee is eligible, the trustee will receive the §330(e) payment on an annual basis, even if no or partial filing fees are collected in a case.



# Section 330(e) Payments

- The amount of the [§ 330\(e\)](#) payment will be determined annually and will be limited by:
  - the availability of excess chapter 11 quarterly fee revenue and
  - the number of cases filed under or converted to chapter 7 during each fiscal year
- The amount of the [§ 330\(e\)](#) payment will be the lesser of:
  - \$60, or
  - a pro rata share of the excess quarterly fee revenue



# Applicable Cases Under BAIA

- All cases filed under chapter 7 on or after January 12, 2021, and through September 30, 2026.
- All cases originally filed under chapters 11, 12, or 13 on or after January 12, 2021, and later converted to chapter 7 on or before September 30, 2026.
- The fiscal year 2021 applicable cases would be:
  - all cases filed under chapter 7 on or after January 12, 2021, through September 30, 2021, *and*
  - all cases originally filed under chapters 11, 12, or 13 on or after January 12, 2021, and converted to chapter 7 by September 30, 2021.



# Applicable Cases Under BAIA, cont.

- For fiscal year 2021, Chapter 7 trustees will need to review all assigned cases filed on or after January 12, 2021 and through September 30, 2021 (or a case originally filed under chapters 11, 12, or 13 on or after January 12, 2021, and later converted to chapter 7 through September 30, 2021).
- Chapter 7 trustees will then need to retroactively make a claim for payment under [11 U.S.C. § 330\(e\)](#) by e-filing a “Trustee Services Rendered Pursuant to §330(e)” event to certify they are eligible for payment.



# Eligible Chapter 7 Trustees

- Section 330(e) of Title 11 provides that the §330(e) payment applies to chapter 7 cases in which the trustee has “rendered services.” [11 U.S.C. § 330\(e\).](#)
- [The Regulations](#) follow the statutory language and provide that a chapter 7 trustee must have “rendered services” to be eligible to receive the new payment.
- “Rendered services” is evidenced when the trustee has performed certain duties and has certified that the trustee is eligible to receive the payment.





# Rendered Services

Rendered services is evidenced by the trustee filing a certification with the court that the trustee has performed one of the following duties outlined in [11 U.S.C. § 704](#) and the Federal Rules of Bankruptcy Procedure in an applicable case:

- (A) Conducting or filing any document required by rule or statute related to a meeting of creditors required by 11 U.S.C. § 341;
- (B) Filing a report of no distribution;
- (C) Filing a notice of assets;
- (D) Filing a motion or notice to dismiss or convert the case or reviewing such a motion filed by another party in the case; or
- (E) Filing the chapter 7 trustee's final report.

See [Section 5 of the Regulations](#).



# Trustees Certification of Eligibility

- A trustee who has rendered services in an applicable case must make a claim for the [§330\(e\)](#) payment.
- The chapter 7 trustee makes such claim by filing a certification with the court certifying that the trustee has rendered services in the applicable case.
- Being appointed as the trustee in an applicable case does not by itself qualify a trustee for the payment.
- New dictionary events (rendered services events) have been created for this purpose.
- Trustees **MUST** use these events to file or withdraw the certification.
- Further [guidance](#) is available on the PACER website.



# Time for Filing Trustees Certification of Eligibility

- For fiscal year 2022 (Oct 1, 2021 to Sept. 30, 2022) through 2026, Chapter 7 trustees may make a claim for payment under [11 U.S.C. § 330\(e\)](#) by filing a “Trustee Services Rendered Pursuant to §330(e)” event to certify they are eligible for payment no sooner than seven days after the trustee has been notified of selection in a case. See, [Fed. R. Bankr. P. 2008](#).
- The certification should be filed no later than 90 days after the later of the following two events:
  - (A) The judiciary posting the annual notice on its public website that payments can commence for the prior fiscal year; or
  - (B) The event that supports the certification that the trustee has rendered services under [subparagraph \(a\)\(3\)](#) of the Regulations.

# There are Two *New Text-Only* Filing Events for BAIA Fees

**1. *Trustee Services Rendered Pursuant to §330(e)*** – to be used by Chapter 7 trustees to certify that they are eligible to receive payment.

**NOTE:** Use of any other CM/ECF event will result in a delay in payment or failure of the Chapter 7 trustee being identified as eligible for payment.

**2. *Withdrawal of Trustee Services Rendered Pursuant to §330(e)*** -- to be used by Chapter 7 trustees to withdraw the *Trustee Services Rendered Pursuant to § 330(e)* event.

**NOTE:** This is the only event that a trustee should use to withdraw the event “Trustee Services Rendered Pursuant to § 330(e)”, which will remove the case from payment.
