ORDER AMENDING LOCAL RULES, FORMS, AND APPENDIX

Pursuant to 28 U.S.C. § 2071, Fed.R.Civ.P. 83, Fed.R.Bankr.P. 9029, and U.S. District Court for the District of Rhode Island General Local Rule 109(h)(1), the following Local Bankruptcy Rules, Forms, and Appendix are hereby adopted effective December 1, 2009.

Local Bankruptcy Rule 1003-1 (amended)
Local Bankruptcy Rule 1007-1 (amended)
Local Bankruptcy Rule 2004-1 (amended)
Local Bankruptcy Rule 2016-1 (amended)
Local Bankruptcy Rule 4001-4 (amended)
Local Bankruptcy Rule 4008-1 (amended)
Local Bankruptcy Rule 5005-4 (amended)
Local Bankruptcy Rule 9010-1 (amended)
R.I. Bankr. Form X (amended)

The following local rules are being amended in order to be consistent with the manner in which time is computed under the federal rule changes, effective December 1, 2009.

- **Two (2) days are extended to seven (7) days in Local Bankruptcy Rules:** 1002-1, 1007-1, 4001-2, 9013-3, and 9014-1.
- **Three (3) days are extended to seven (7) days in Local Bankruptcy Rule:** 3020-1.
- **Five (5) days are extended to seven (7) days in Local Bankruptcy Rules and Forms:** 1005-1, 1017-2, 2015-5, 4001-1, 9010-1, 9013-2, 9072-1, R.I. Bankr. Form T, R.I. Bankr. Form T.1.
- **Ten (10) days reduced to seven (7) days in Local Bankruptcy Rules:** 5005-5, 9027-1.
- **Ten (10) days are extended to fourteen (14) days in Local Bankruptcy Rules and Forms:** 1005-1, 2004-1, 3007-1, 3015-1, 3015-3, 3018-2, 4001-1, 4001-4, 4003-1, 4004-1, 7026-1, 9013-2, 9014-1, 9072-1, R.I. Bankr. Form K.2.
- **Eleven (11) days are extended to fourteen (14) days in Local Bankruptcy Rule:** 3015-3.
- **Thirteen (13) days are extended to fourteen (14) days in Local Bankruptcy Rules:** 2004-1, 4001-1.

- **Fifteen (15) days are reduced to fourteen (14) days in Local Bankruptcy Rules:** 1002-1, 1006-1, 1007-1, 2016-1, 2083-1, R.I. Bankr. Form W.1.
- **Twenty (20) days are extended to twenty-one (21) days in Local Bankruptcy Rules, Forms, and Appendices:** 1005-1, 2017-1, 3011-1, 3015-2, 4002-2, 5005-4, 7016-1, Appendix IV, R.I. Bankr. Form E, R.I. Bank. Form Q, R.I. Bankr. Form W.2.
- **Twenty (25) days are extended to twenty-eight (28) days in Local Bankruptcy Rules:** 1006-1, 2002-1, 3020-1, R.I. Bankr. Form L.

Other technical amendments include:

Local Bankruptcy Rules 1002-1, 1009-1, 1019-1 are amended to remove all references to “Mailing Matrix” and/or “Matrix”, and said text will be replaced with, “Creditor List”.

Local Bankruptcy Rules 1002-1, 1007-1, 2083-1 are amended to remove all references to “Notice of Missing Document and Notice of Automatic Dismissal for Non-compliance” and “(2) Day Notice of Missing Document and Notice of Dismissal if Documents are not Timely Filed”. This text will be replaced with “Order to file Missing Document and Notice of Automatic Dismissal for Non-Compliance”.

The referenced amended rules, forms, and appendix take effect on December 1, 2009 and shall apply to all cases filed on or after this date, and all cases pending in this Court as of this date.
