Notice of Upcoming Bankruptcy Miscellaneous Fee Changes

Effective: December 1, 2020

PLEASE TAKE NOTICE:

At its March 2020 session, the Judicial Conference approved adjustments to the Bankruptcy Court Miscellaneous Fee Schedule, which go into effect December 1, 2020 (*see* attached).

Of note is the **increase to the administrative fee assessed at filing in every bankruptcy case**. The administrative fee for filing a Chapter 7, 12 and 13 case is now \$78, and \$571 for filing a Chapter 9, 11, and 15 cases.

Combining the revised administrative fees with the current statutory fees, **the total new filing fee for each chapter will be as follows:**

- For filing a petition, or for filing a motion to divide a joint case, under **Chapter 7: \$338**
- For filing a petition, or for filing a motion to divide a joint case, under **Chapter 12: \$278**
- For filing a petition, or for filing a motion to divide a joint case, under **Chapter 13: \$313**
- For filing a petition under **Chapter 9, 11, or 15: \$1,738**
- For filing a motion to divide a joint case under Chapter 11: \$1738

Attached to this Notice is a chart of all revised miscellaneous bankruptcy fees effective December 1, 2020.
