#### **COVERAGE PERIOD OPTIONS:**

September 1, 2023 through August 31, 2024 (one year) with one (1) option to renew for one (1) additional year (September 1, 2024 – August 31, 2025)

September 1, 2023 through August 31, 2025 (two years)

The United States Bankruptcy Court for the District of Rhode Island (Court) is seeking quotations for monthly parking arrangements. This is a request for **<u>Open Market Pricing</u>**. Pricing is being solicited to award one of the following<sup>1</sup>:

- A 12-month contract (base) with one (1) option to renew for an additional one (1) year contract.
- A 24-month multi-year contract.

## **SERVICE REQUIREMENTS:**

1. Parking spaces not to exceed 7 vehicles.

<sup>&</sup>lt;sup>1</sup> Base year (Option to Renew) commits the Court to a one-year contract. The Court *may* renew the contract for the additional 12 months at the pricing quoted in this RFQ however, we have the option to let the contract expire after the end of the first year. Multi-year contracts commit the Court to a contract for the entire length of time specified.

2. Minimum parking availability options: Weekdays 6:00 a.m. to 8:00 p.m.

3. Flexibility to allow the ad hoc usage of the contracted parking spaces to court personnel as needed [seven (7) court staff members telework one day each week].

4. Monthly billing statements.

5. Parking spots can be no further than 0.3 miles from the perimeter of the Federal Center, 380 Westminster Street, Providence, RI

6. In and out privileges during the day.

7. The Court reserves the right to decrease the number of monthly spaces should its needs change. Any change in the number of spaces per month will be made in writing at least 15 days before the next billing cycle.

## **EXERCISING OPTION YEARS:**

If the contract is awarded on the terms of base year plus options, the Court will notify the service provider at least thirty (30) days prior to the end of the contract year if it will exercise the right to utilize the subsequent option year term.
