Introduction

BANKRUPTCY RULE 1007(b)(7)

As an approved personal financial management course provider, you are now allowed to file the certificate of completion of the post-petition personal financial management course for debtors directly with the court. Bankruptcy Rule 1007(b)(7) was amended to streamline this process and went into effect on December 1, 2013.

- As an approved personal financial management course provider, you will be filing personal financial management course certificates on behalf of debtors.
- Training material for filing these certificates in the Rhode Island Bankruptcy Court are included in this document.

Deadlines associated with filing certificates of debtors' completion of this course are critically important to the debtor and your responsibilities as an approved course provider.

- In a chapter 7 or 13 case, if the statement of the debtor's completion of the course is not filed within 60 days after the first date set for the §341 meeting, amended Fed. R. Bankr. P. 5009(b) will require the clerk to notify the debtor that the case will be closed without entry of a discharge unless the statement is filed within the applicable deadline under Fed. R. Bankr. P. 1007(c).
- In a chapter 11 or 13 case, this certificate of completion must be filed no later than the last payment made by the debtor as required by the plan.

The risk to the debtor, if the provider fails to timely file the certificate, is that the debtor's case could be closed without a discharge. See Fed. R. Bankr. P. 4004(c)(1)(H).

The Court may notify the Executive Office of the U.S. Trustee, or take such other action as appropriate, if the provider does not file certificates in a timely manner, causing the debtor's case to be closed without a discharge.

NOTE: If you do not know the debtor's case number, or the name and case number do not match the debtor, you can click Query from the CM/ECF tool bar and enter the debtor's name to obtain the case number. In order to do so, you will be prompted to enter your *PACER password.

*Contact <u>the PACER Service Center</u> to receive a login and password for querying.

Steps for Filing the Certificate of Completion of a Personal Financial Management Course

The following pages provide the steps to electronically file a personal financial management course certificate in the debtor's case in the U.S. Bankruptcy Court for the District of Rhode Island.

STEP 1 Internet Access

To access the RI Bankruptcy Court website, open your browser and enter http://www.rib.uscourts.gov in the browser's address field. (See Figure 1) Each court will have its own unique address.

NOTICE TO APPROVED PERSONAL FINANCIAL MANAGEMENT COURSE PROVIDERS

Iffective December 1, 2013, Federal Rule of Bankruptcy Procedure 1007(b)(7) has been amended to permit an pproved debtor education provider to notify the court directly that the debtor has completed a post-petition nstructional course concerning personal financial management.* This rule change pertains to **debtor education ertificates only**, not to credit counseling certificates.

he Bankruptcy Court for the District of Rhode Island will permit approved personal financial management course roviders to file the Certificate of Debtor Education under Rule 1007(b)(7), electronically using the electronic nancial management course certificate filing program (eFinCert) instead of requiring course providers to register s a limited filer in the court's CM/ECF case management system.

ursuant to Federal Rule of Bankruptcy Procedure 1007(c), the debtor must file a statement that he/she ompleted the personal financial management course within 60 days after the first date set for the meeting of reditors under § 341 of the Code in a chapter 7 case, and in a chapter 11 or 13 case no later than the date when ne last payment was made by the debtor as required by the plan or the filing of a motion for discharge under § 141(d)(5)(B) or § 1328(b) of the Code. Failure by the provider to timely file the certificate in accordance with Fed. 8. Bankr. P. 1007(c), will result in the debtor's case being closed without a discharge. See Fed. R. Bankr. P. 4004 c)(1)(H).
